Meeting opened with prayer by Donnie Phelps.

Utility Meeting

Morris Vaughn was not present & his report was given by Robbie Gossett.
Reported leaks (3) that were in the month, also having some problems with pumps.
Robbie reported more people were signing up on the Jacksonville project.

There was a fellow present asking about H2O to a trailer park on KY 1247, needs 7 meters.
City will set meters but all H2O lines will be done by owner.

Heard report from Dallas Blanton. Reported 98.5 bod & 94.5 solids removed N @ 90.2%.
Talked about smoke test that was done, some manholes had leaks but were fixed.
Main test went well.

Dallas talked about video camera for the City to check sewer lines
Cost at approx. \$8500.00 but in order to cover everything it would be around \$1500.00
more to total \$10,000.00. Maybe the City could rent out the unit to some smaller cities to
help in cost or could get reimbursed thru Sewer project.

This was tabled at present – no action.

Had another visitor present asking about sewer out to the Desota Vaught property on
the Frog Hollow Rd. Was told may be run in the future.

Donnie had check in the amount of \$600,000.00 that was picked up by Robbie & David
Phelps from PRIDE (a waste water construction grant), will get more at a later date for
Sewer project.
