Paul Cassada and Dallas Blanton were not present also Charles Wright.

Robbie Gossett gave H2O report, reported – 1 ¾% loss, and Monthly Operating Report was handed out, Dug and repaired 2 water lines on U.S. 27, fixed leak on Frog Hollow Rd.

City is required to start testing for Microbiological Residue in the System. This problem is caused by break down of chlorine. These test will be taken from 8 sites twice a month and will be taken for 6 periods. This is required by the State. If no problems is found, testing in the future will cease. The Cost to the City will be \$20,000.00.

David Young gave Sewer report, he reported BOD 99.2%, Solids 99.0% and N at 98.0%. Had Zero exceptions for Oct. Still having problems with pump at Park, did install new pump at main lift Sta. Fixed lift Sta. at Sonya Morris' again.

It was reported Sewer Const. is moving forward, and the bore under U.S. 27 is being Completed by Gary Price and finished by the end of Dec. He is pulling old 32" casing and replacing with new 36" casing.
